

OFFICIAL RULES FOR SENTRY INSURANCE

To Enter: Participants may enter in person by completing the entry form via the iCapture iPad application at the SentryWorld Sports Center Pro Shop at 601 N. Michigan Avenue, Stevens Point, Wisconsin 54481 or register online by opting into the email newsletters at www.sentryworld.com. Limit one (1) entry per person during each Promotion Period. If participants wish to enter more than once during the entire Promotion, they must complete the entry steps for each Promotion Period for which they wish to participate. To be deemed valid, entries must be fully and accurately submitted in accordance with the requirements imposed in these Official Rules. Sponsor is not responsible for lost, late, incomplete, incorrect, damaged, or misdirected entries or prize claims.
